The 2021 <u>High-Level Political Forum on Sustainable Development (HLPF)</u> will focus on **Sustainable Development Goals 1** (eradication of poverty), **2** (zero hunger), **3** (good health and well-being), **8** (decent work and economic growth), **10** (reduced inequalities), **12** (responsible consumption and production), **13** (climate action), **16** (peace, justice and strong institutions), and **17** (partnerships).

- Highlight the commitment of Catholic Religious congregations to the fulfilment of SDGs in Spain and other countries who will be presenting Voluntary National Reviews in 2021
- Present a model of national-level SDG monitoring by women and men Religious in Spain that could inspire and inform Religious in other countries to become more deeply engaged in their national civil society network that monitor national SDG implementation
- Underscore the value of faith leaders' engagement with governmental policy and programming as a pathway to greater social, economic, and environmental sustainability
- ❖ Initiate collaboration between REDES and JCoR networks that will improve unity and strength of Catholic Religious voices in the field of advocacy on SDGs
- Strengthen the spirit of collaboration between Catholic Religious actors and government officials toward achievement of the SDGs

  - 1. SDGs 2 & 3: Augustinian Recollect International Solidarity Network
    (ARCORES) in the Philippines: Launching of Kindness Bakeries, which
    produce bread for hospitals and for poor and remote communities affected by the
    COVID-19 crisis, and distribution of the bread (and other food rations) at
    "Kindness Stations," facilities that are accessible to marginalised families during
    the COVID-19 lockdowns
  - 2. SDGs 3 & 5: Sisters Hospitallers of the Sacred Heart of Jesus (Benito Menni) in Mozambique: Strengthening and expansion of care in the field of mental health and disability in the context of COVD-19 at Mahotas Psychosocial Rehabilitation Center, which was founded by AECID and is dedicated to the rehabilitation of children, youth and adults with disabilities and mental health problems
  - 3. **SDGs 4 & 8:** Salesian Missions in Haiti: Creation & adaptation of academic & skills training content for distance training during pandemic using a training platform has been designed with support from Spanish National Development Agency (AECID) and Madrid Regional Government.
  - 4. SDG 12 and 13: Sister for Christian Community, Ana Martinez De Luco, in the United States of America: creation and direction of Sure We Can, a non-profit, homeless-friendly center for redemption of recyclable and organic materials and for urban gardening and sustainability education in New York City Our practitioners will also offer observations and recommendations to help guide governmental and other civil society leadership toward new strategies and partnerships with the capacity to accelerate SDG achievement while leaving no one behind.
