### THE UN CHARTER:

#### WE, THE <u>PEOPLES</u> OF THE UNITED NATIONS, DETERMINED

- to save succeeding generations from the scourge of war, which twice in our lifetime has brought untold sorrow to mankind, and
- to reaffirm faith in fundamental human rights, in the dignity and worth of the human person, in the equal rights of men and women and of nations large and small, and
- to establish conditions under which justice and respect for the obligations arising from treaties and other sources of international law can be maintained, and
- to promote social progress and better standards of life in larger freedom,

### THE UN CHARTER:

#### AND FOR THESE ENDS


- to practice tolerance and live together in peace with one another as good neighbours, and
- to unite our strength to maintain international peace and security, and
- to ensure, by the acceptance of principles and the institution of methods, that armed force shall not be used, save in the common interest, and
- to employ international machinery for the **promotion of the** economic and social advancement of all peoples...

### Aims to establish global consensus & accountability toward realization of:

- Universal human rights (UDHR)
- Civil & political rights (ICCPR)
- Economic, social, and cultural rights (ICESCR)
- Elimination of discrimination against women (CEDAW)

- Rights of migrant workers & their families (CMW)
- Rights of persons with disabilities (CRPD)
- Rights of children (CRC)
- Elimination of racial discrimination (CERD)



#### **MEDITATION ROOM** at UN HEADQUARTERS

"We all have within us a center of stillness surrounded by silence. This house, dedicated to work and debate in the service of peace, should have one room dedicated to silence in the outward sense and stillness in the inner sense. It has been the aim to create in this small room a place where the doors may be open to the infinite lands of thought and prayer."

Because people of many faiths meet here, UN leaders sought to adorn this space with "simple things which speak to us all with the same language," namely a shaft of light striking the shimmering surface of solid rock.

#### Shaft of light:

"Symbol of how, daily, the light of the skies gives life to the earth on which we stand, a symbol to many of us of how the **light of the spirit gives life to matter.** 

#### Stone in the middle of the room:

"We may see it as an altar, empty not because there is no God, not because it is an altar to an unknown god, but because it is **dedicated to the God whom man worships under many** names and in many forms."

Sign of **firmness and permanence** in a world of movement and change "Reminder of that **cornerstone of endurance and faith on which all human endeavour must** be based."

#### Material of the stone: iron ore

"Leads our thoughts to the necessity for choice between destruction and construction, between war and peace. Of iron man has forged his swords, of iron he has also made his ploughshares. Of iron he has constructed tanks, but of iron he has likewise built homes for man. The block of iron ore is part of the wealth we have inherited on this earth of ours. How are we to use it?"

#### Room of utter simplicity:

No other symbols, only a simple pattern on the front wall Opens the room to the "harmony, freedom and balance of space" "There is an ancient saying that the sense of a vessel is not in its shell but in the void. So it is with this room. It is for those who come here to fill the void with what they find in their center of stillness."

### The POLITICAL is SPIRITUAL

"The United Nations and its agencies deal with a comprehensive range of issues affecting global communities, including human rights, population, food, agriculture, health, trade and children. 
### The SPIRITUAL is POLITICAL



## How Religious Congregations Engage with the UN System

### Catholic Religious NGO Presence at the UN

 In the UN system, we are considered NGOs (nongovernmental organizations)

 ~30 NGOs accredited to represent over 200 Catholic Religious congregations



# What does it mean to be accredited?

Accreditation allows our NGOs to participate in UN proceedings by:

- Making oral statements
- Submitting written statements
- Meeting with diplomats
- Participating in UN conferences
- Sponsoring events inside and near UN Headquarters
- Making formal or informal recommendations on new UN agreements as they are being negotiated
- Submitting reports and comments on nations' progress on human rights (or lack thereof)

# **Religious Voice** at the UN

- Expert: provide insights from members' work ministering to the poorest and most vulnerable populations "on the ground"
- Impartial: represent communities that span many nations and have no national identity
- **Credible:** known to *practice* values of care for human dignity of all and for the natural environment through lives of intentionality and dedicated service
- **Consistent:** maintain positions based on constitutions and principles older than UN and many nations; bring continuity and stability to global conversation that governments with frequently changing leaders/politics cannot
- Collaborative: speak and work through coalitions and committees that model for governments how to prioritise common goals and common good ahead of individual glory or achievement

INTERNATIONAL RESEARCH ON FAMILIES

I wanted to move, but couldn't afford it. I had no option but to live with the water in my house, waiting for the water to dry up. It is not yet dried up. I have been living in the same place for 15 years now, and each year it is the case that it has flooded. This time I was forced to pour some garbage in front of the door to make a space to pass. I cannot go to the toilet at night because it is far away outside and there is no sight, I can't see [not to step in water]. Despite living 15 years there I am lucky. I am lucky that I have never been contracted with cholera. I stay at the center of where the flood water comes to. For that reason the flood water has actually stayed near my home for close to five years, and it even turns its color. When the rains are over the water turns into some sort of black color - its from the sewage system.

#### SIGNS OF THE TIMES: a CALL to COALITION

- Smaller numbers of vocations to Religious life requires creative approaches to ministry that allow us to benefit from the wisdoms of our unique charisms as well as from the strength of our common mission.

As a global community dedicated to the poor, the oppressed, and the earth, we are called to engage in the HLPF to hear how our political leaders tell the story of our national realities and to bring the stories and concerns of the marginalised into the center of the global conversation on development.
