We have, for most of human history, imagined that the solution to poverty was growth:





Low-income countries allocate more than 2x as much funding to debt interest payments as they do to social assistance

1.4x more than to healthcare

Help us to approach the substance and lifeforms of this planet with reverence.





Help us to savor life's purest blessings enough to live simply with great joy.



Help us to receive—with grace and reverence—the gifts of resources, time, talent, and wisdom that may be offered to us by our sisters and brothers from every background.




God, help us to grow in solidarity.

What is CSocD62?

What is Social Development?

Social development is an approach to development which recognizes that the ability of a society to thrive depends upon the well-being of each and every one of its citizens. Therefore, social development requires investing in people to ensure that their age, physical ability, income level, or other factors do not prevent them from living with dignity. It is the process of **removing barriers to opportunity and creating new pathways to well-being to ensure all people can reach their full potential and contribute meaningfully to their communities**.

What is the Commission for Social Development?

The Commission for Social Development (CSocD) is a conference that serves as a **platform for United Nations (UN) Member States, civil society, and other stakeholders** to come together to discuss recommendations and policies **to advance social development** at both the national and global levels. It focuses on reducing inequalities among various groups through poverty eradication, social inclusion, and sustainable development for all. The CSocD agenda includes space to share good practices, review and analyse progress, engage in policy dialogues, and coordinate efforts to advance social development - thereby improving the well-being of individuals and communities worldwide.

What is the theme for CSocD62?

Each year, the Commission adopts a priority theme and emerging issue to guide its efforts. The theme for the 62nd Session of the Commission for Social Development (CSocD62) will focus on this central theme: **Poverty eradication through policies that reduce inequality and advance social justice**. It will also discuss the emerging issue: Digital technology's influence on social inequality.

Key Terminology

The following terms provide an important foundation for understanding the global policy conversation on social development. You will want to be familiar with them if you plan on participating in or following the discussions at CSocD62.

Poverty

Condition characterized by severe deprivation of basic human needs, including food, safe drinking water, sanitation facilities, health, shelter, education and information; depends not only on income but also on access to services

Policies and programmes intended to help keep all people at or above a minimum standard of living that reflects their human dignity (e.g., cash transfers to ensure every household has access to a certain minimum amount of money to spend on basic goods, direct provision of food, and special access to low-cost housing)

Minimum standards of income, housing, healthcare, nutrition, etc. that enable one to live in dignity in a specific nation or locality

Increase in economic productivity that benefits all people rather than only those in the highest levels of leadership or ownership

Social protection

JCoR's Recommendations

In their reports on poverty and social policies, JCoR's regional network members called for these actions to be taken by the world's governments:

- Facilitate access of small-holding farmers and entrepreneurs to irrigation systems, to urban markets (via sufficient roads and affordable transport options), and to international markets (via fair trade agreements upholding workers' rights)
- Organize and incentivise investors to offer vocational training, access to microcredit, and support for local entrepreneurship in marginalised and remote communities
- Remove all legislative barriers to women's ownership of land and support community-based deconstruction of stigmas and traditions preserving de facto barriers to it
- Establish a liveable minimum wage and guarantee basic income through a public fund and distribution mechanism that is need-based, trauma-informed, and responsive to outreach needs of poverty-burdened communities
 - Foster the establishment of—and channel international and domestic socialservice funding through—community-based women's networks (e.g. Kudumbashree networks in India, Ethiopia, and South Africa)
 - Adopt a rights-based, comprehensive national approach to poverty eradication that includes measurable targets, timelines, and transparent reporting mechanisms consistent with the Sustainable Development Goals and evaluate progress through a peacebuilding lens
 - Dedicate public funds to establishing or preserving community centers for all community-based associations and organizations aligned with human rights and sustainable development

Offer essential social services according to need regardless of migratory status

Fully fund, in proportion to States' common but differentiated responsibilities, all funds of the Framework Convention on Climate Change's financial mechanism and all UN agencies' budgetary requirements for the fulfilment of the social protection needs of refugees and asylum-seekers

End all subsidies for fossil fuel extraction and incentivise cleanenergy development and reforestation

Integrate peacebuilding and anti-poverty initiatives, prioritising and investing in leadership of rural and indigenous women and **children** in both

Enlist leadership from poverty-burdened groups in each locality for building and renovating school infrastructures, training teachers, and tailoring learning programs to local realities and needs;

Prioritise health and education centers in extension of electricity and internet to rural communities

Establish regular migratory pathway for climate-displaced persons and lower ceilings on remittance fees

Enact the SDG Stimulus Plan for **international debt relief**

NGO CSocD's Recommendations

Key demands from the 2024 Civil Society Declaration:

- Establish nationally owned, human rights-based, social protection systems and floors for all
- Ensure equal access to healthcare, education, digital technology, affordable housing and food for all
- Extend debt relief for the least developed countries based on solidarity
- Ensure equal access to a healthy and safe environment for all
- Ensure that all persons are equal before the law, without discrimination

3-Step Reflection

1. Survey of personal and congregational expertise 2. Survey of opportunities 3. Selection of priorities

Step 1: Survey of personal & congregational expertise

Looking into your heart and history...

- 1. What people, places, and social issues/types of ministry do I know most deeply?
- 2. With what people, places, and social issues/types of ministry does my congregation have the strongest history and relationship?
- 3. What questions do I need answered to better serve the people in the places we know most deeply facing the social issues my congregation knows best?

Step 2: Survey of Opportunities

Looking at the programming included in CSocD62...

- 1. When/where might I hear from a representative of my national government or the governments of other countries where my congregation is present?
- 2. When/where are other leaders/experts from these countries speaking?
- 3. When/where can I hear from other experts in the field of my ministry?

Step 3: **Selection of Priorities**

Looking at the programming included in CSocD62...

- 1. Which sessions' topics align most closely with my personal passion, ministry, and questions?
- 2. Which sessions' topics align most closely with my congregation's charism and current priorities?
- Which panelists are best equipped to answer my questions? 3. 4. In which sessions am I most likely to gather contact information
- of helpful future partners in mission?



Daily reflection questions for CSocD62

- What did I learn today that can support my ministry/the community I serve?
- What did I hear today that does not align with or accurately reflect the lived reality of the community I serve?
- Who (person, government, or organization) did I hear from today that I would like to communicate with further?



Crafting Your Message for CSocD62





3-Step Reflection

1. Consider the communities you serve and your congregation

2. Consider your ministry itself

3. Consider the role of government

STEP 1:

When I think of the people my congregation and I serve...

- What barriers to opportunity are they experiencing? \bigcirc
- Where/how is a *lack of* opportunity contributing to their \bigcirc impoverishment?
- What new pathways to well-being are needed to allow \bigcirc them to reach their full potential and to contribute meaningfully to their societies?



When I think of my ministry...

Where/how are we removing barriers to opportunity or creating pathways to contribution and well-being for the community we serve?

STEP 3:

When I think of the services, programs, or support our government provides...

- Where/how is the local or national government removing barriers to \bigcirc opportunity in the community I serve?
- Where/how is the local or national government creating or \bigcirc exacerbating barriers to opportunity for the community I serve?
- How could government create new or better pathways to \bigcirc contribution from community members whose potential to contribute is not being fully realized?
